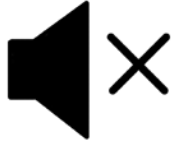

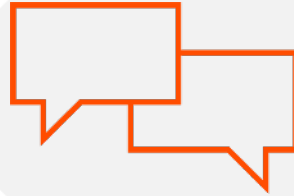

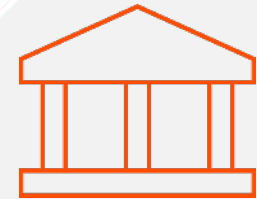

Understanding AXON



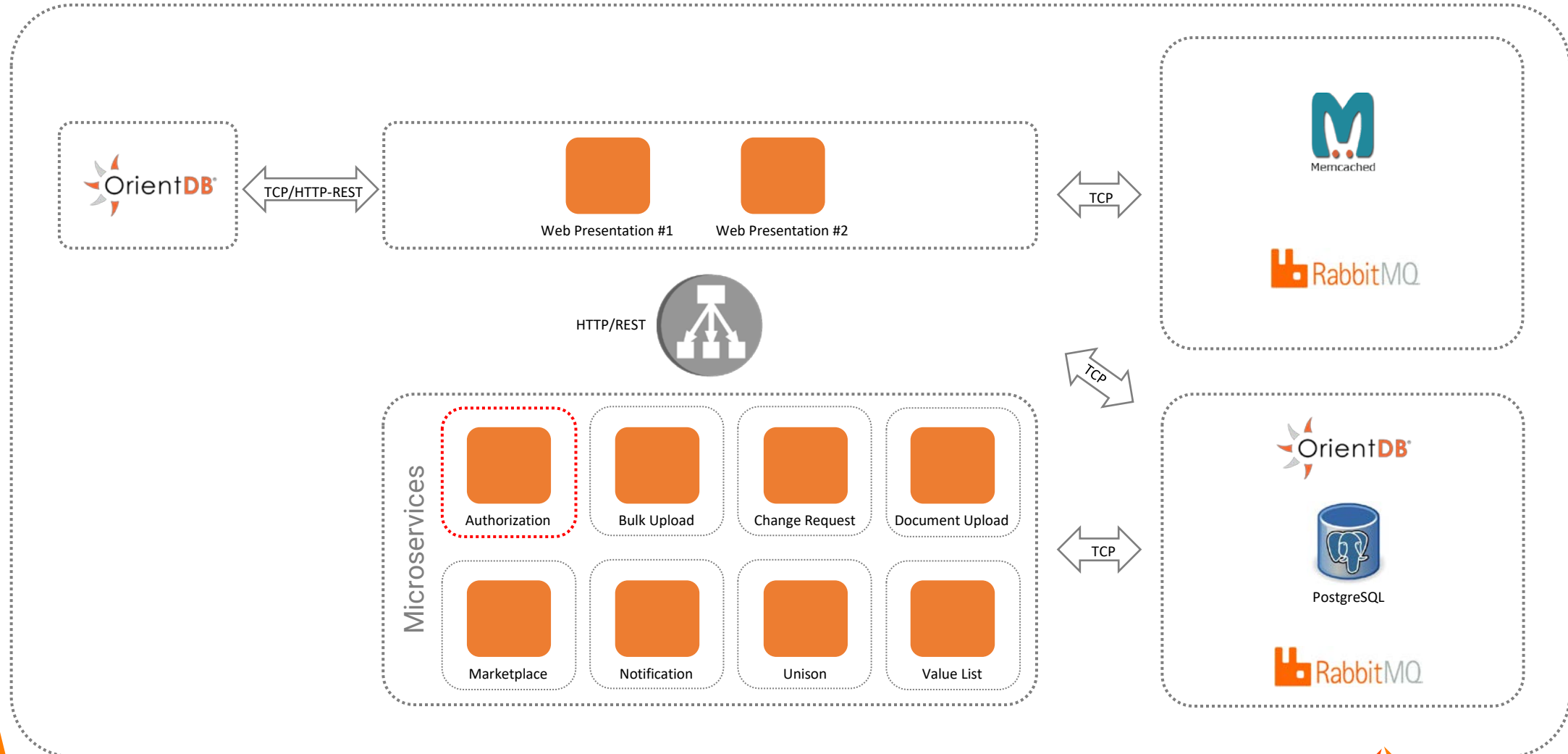
- AXON Organizes Enterprise Data in Facets, Also called Inventories which lists different things in use around your organization. The facet construct was created to help users review content with some form of meaningful structure that separates different types of assets.
- Informatica Axon has 25 facets in total that you can use to describe different aspects of your organization and govern the data items as necessary. All facets in Axon are interconnected
- Over Period of time you'll create a powerful context and knowledge graph, that scales naturally as you continue to add more content to represent an ever-increasing number of Use Cases
- You'll only want to populate Axon facets with objects that are directly relevant to your DG Use Case



AXON Data Governance

- Data Governance is effective collection of practices and processes which help to ensure the management of Data, Policies, Stakeholders etc. within an organization, Consume and adopt the assets based on business evaluation and changes in compliance's within Organization or Government enforcements
- Informatica Axon Data Governance (Axon) is a powerful tool for describing how, why and where data is used in your organization, giving much needed context to this activity. Axon facilitates collaboration between different communities, who may not always realize how they depend upon each other or use the same resources
- Modern Data Governance (DG) isn't just about data, it's about what happens to/with it,
 - and why – this is often contextualized by the processes that consume data, and the policies and regulations that control how it is used.
- Axon gives users the chance to combine these activities and describe the multiple, independent, perspectives surrounding its use. By bringing these together we can show everything fits together

Axon Architecture Overview

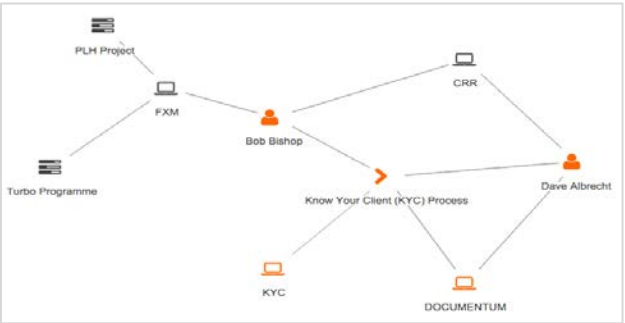

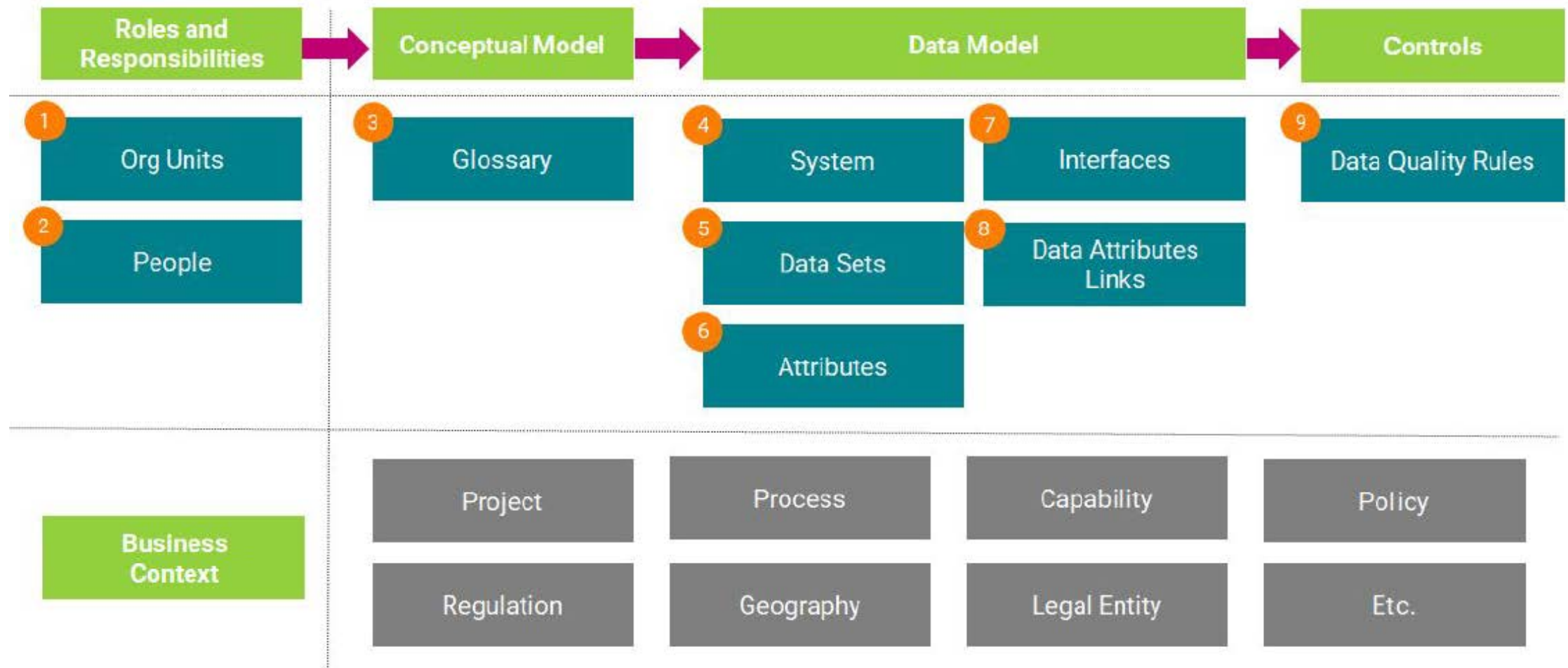

Axon Facets and Data Flow

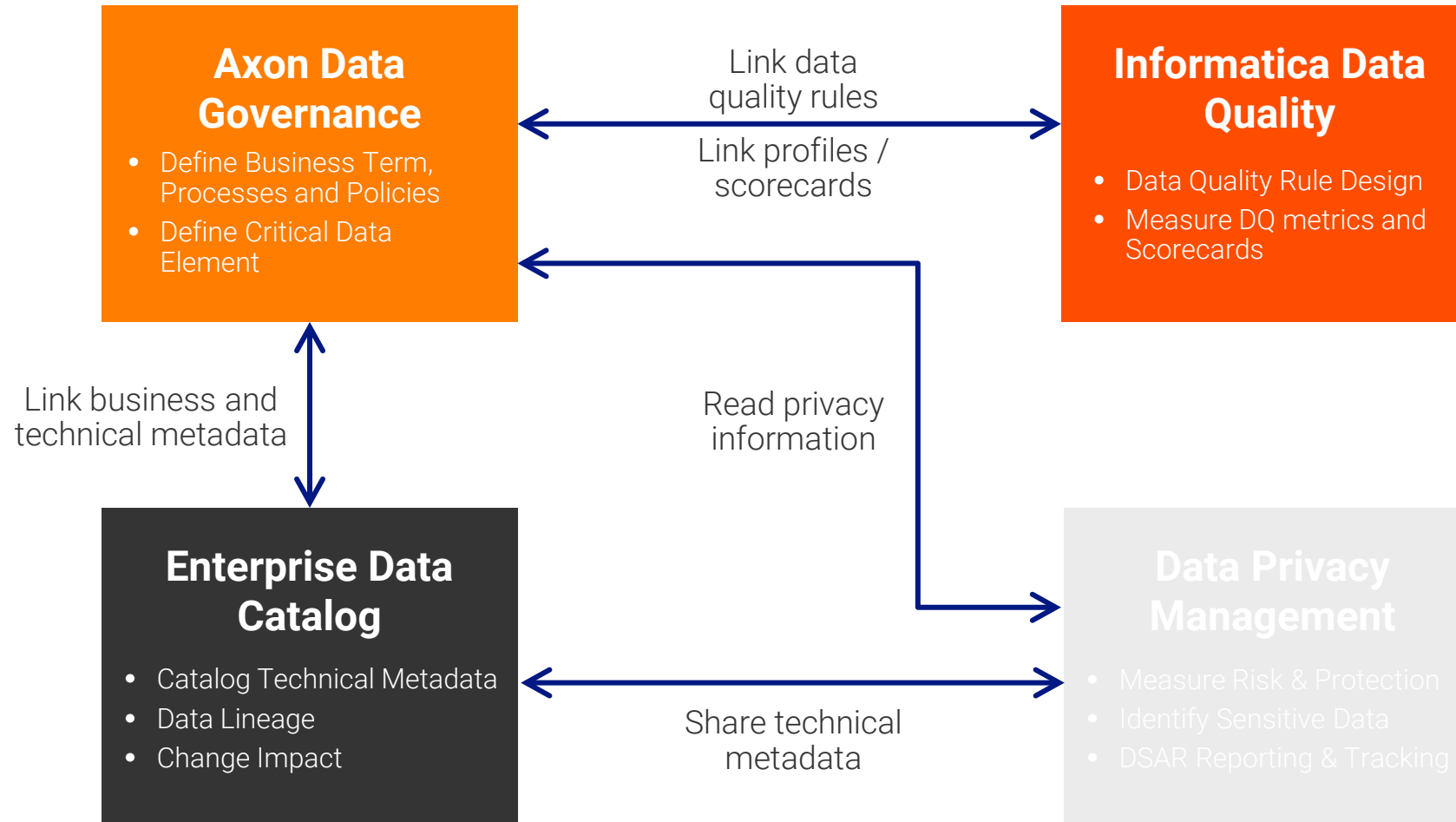

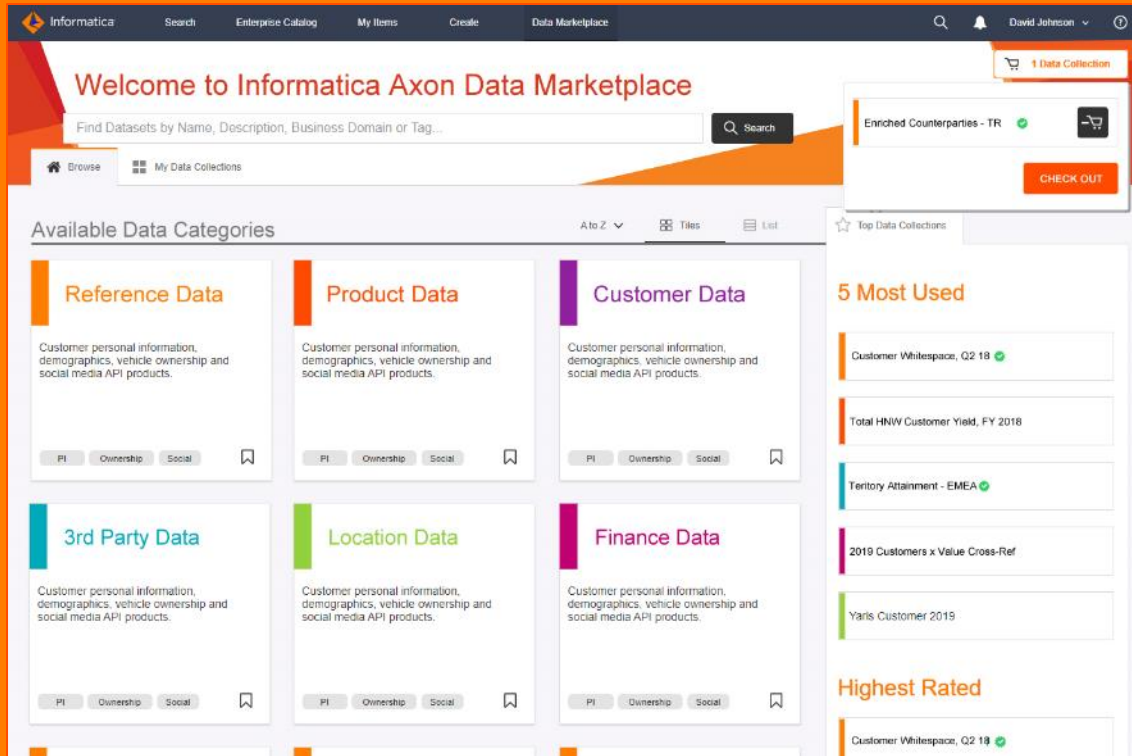

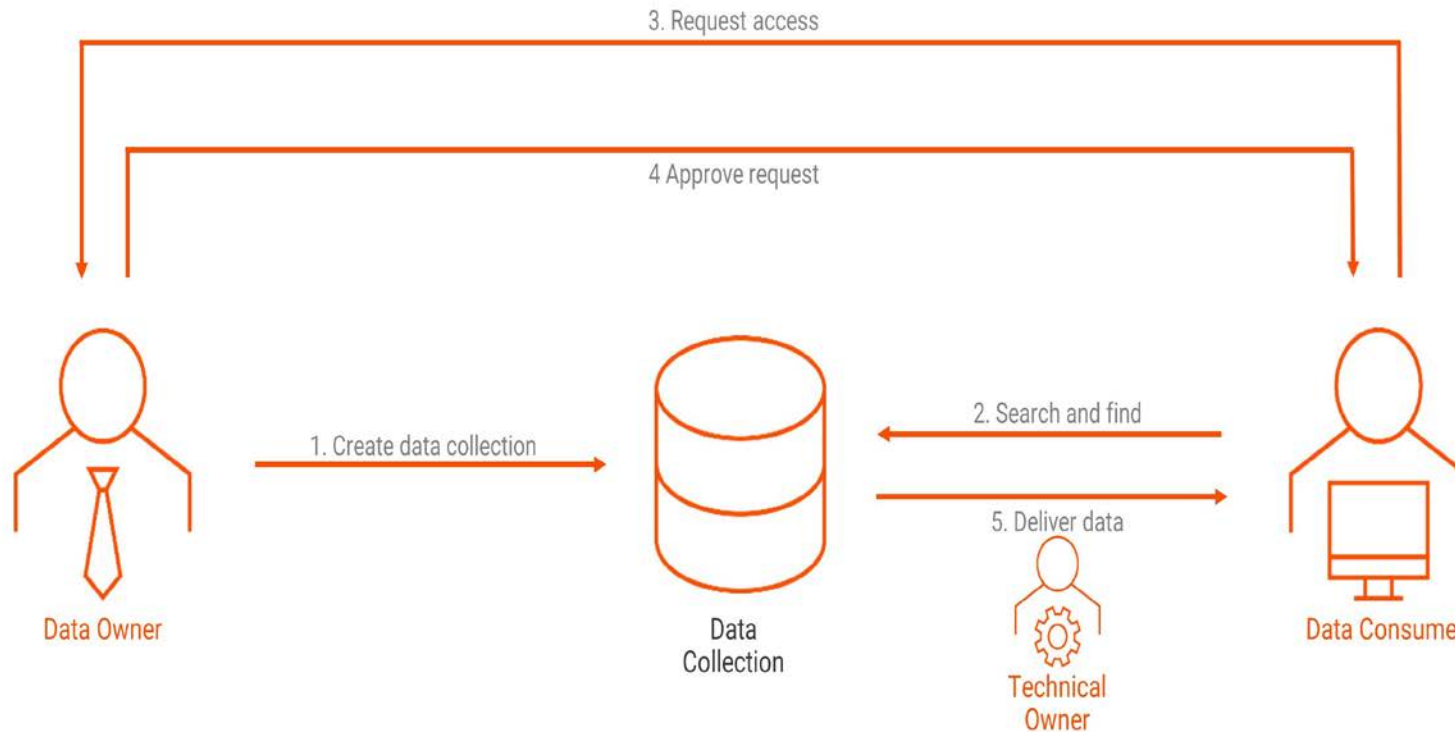

How Data Marketplace Works

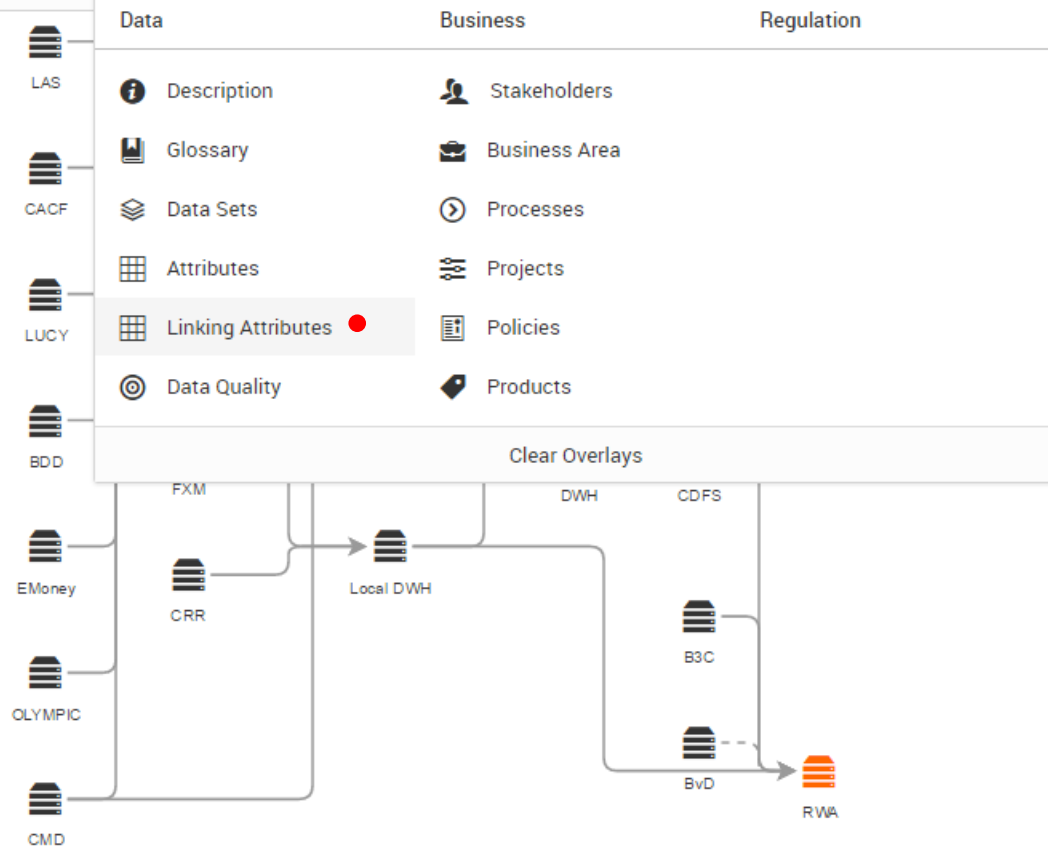


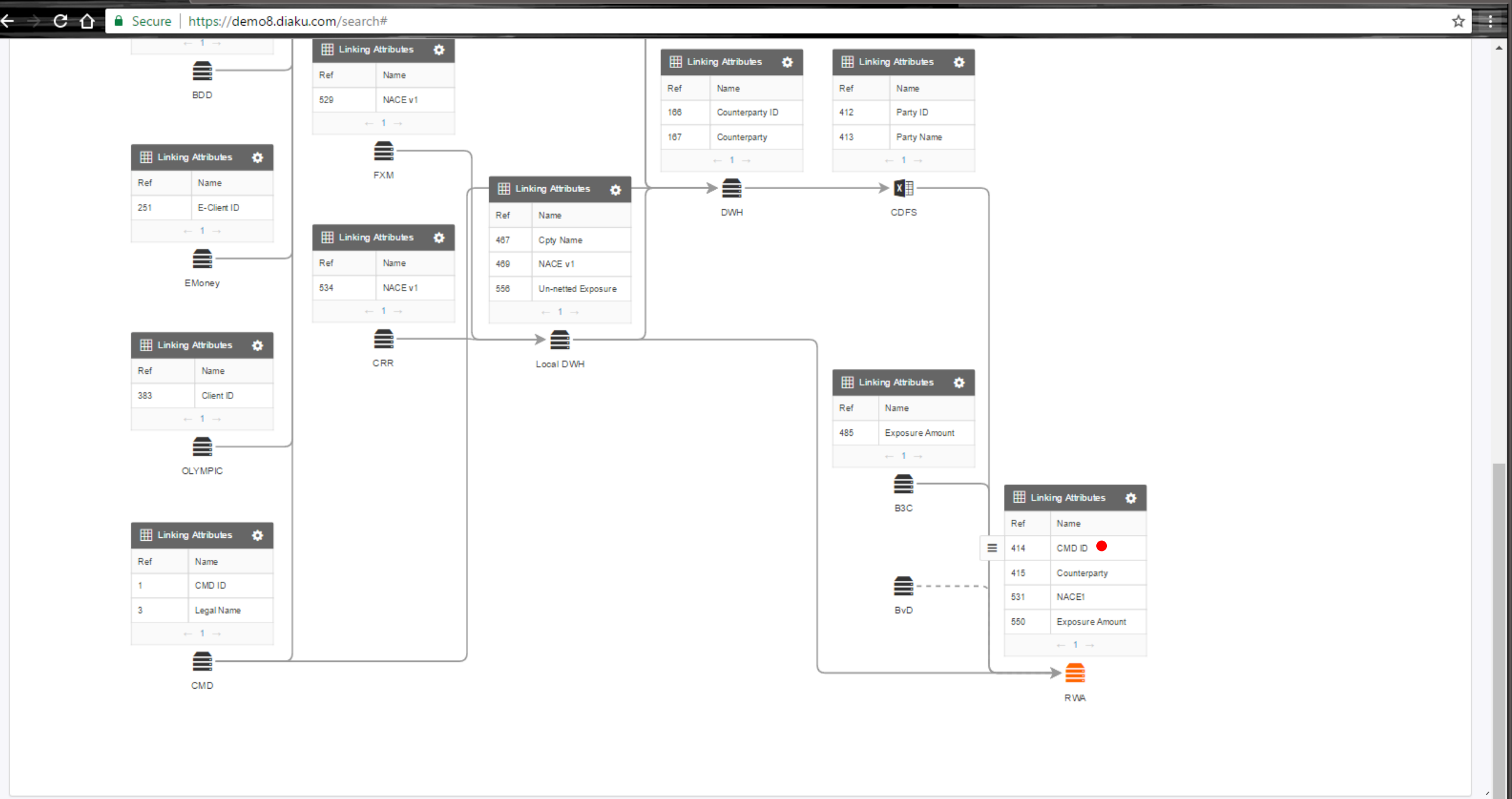
- *The data owner publishes data sets to the Data Marketplace as a data collection.*
- *The data consumer searches the Data Marketplace and find a data collection.*
- *The data consumer requests access to the data from the data owner.*
- *The data owner approves the request.*
- *The technical owner delivers the data to the data consumer.*

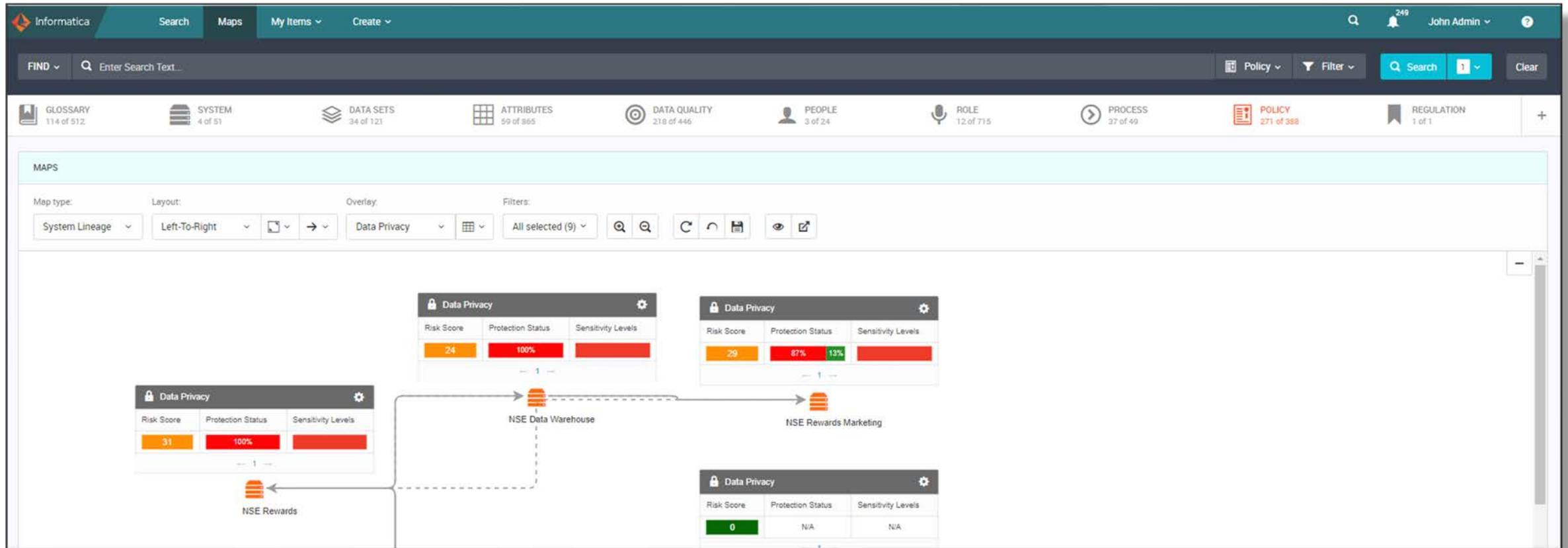

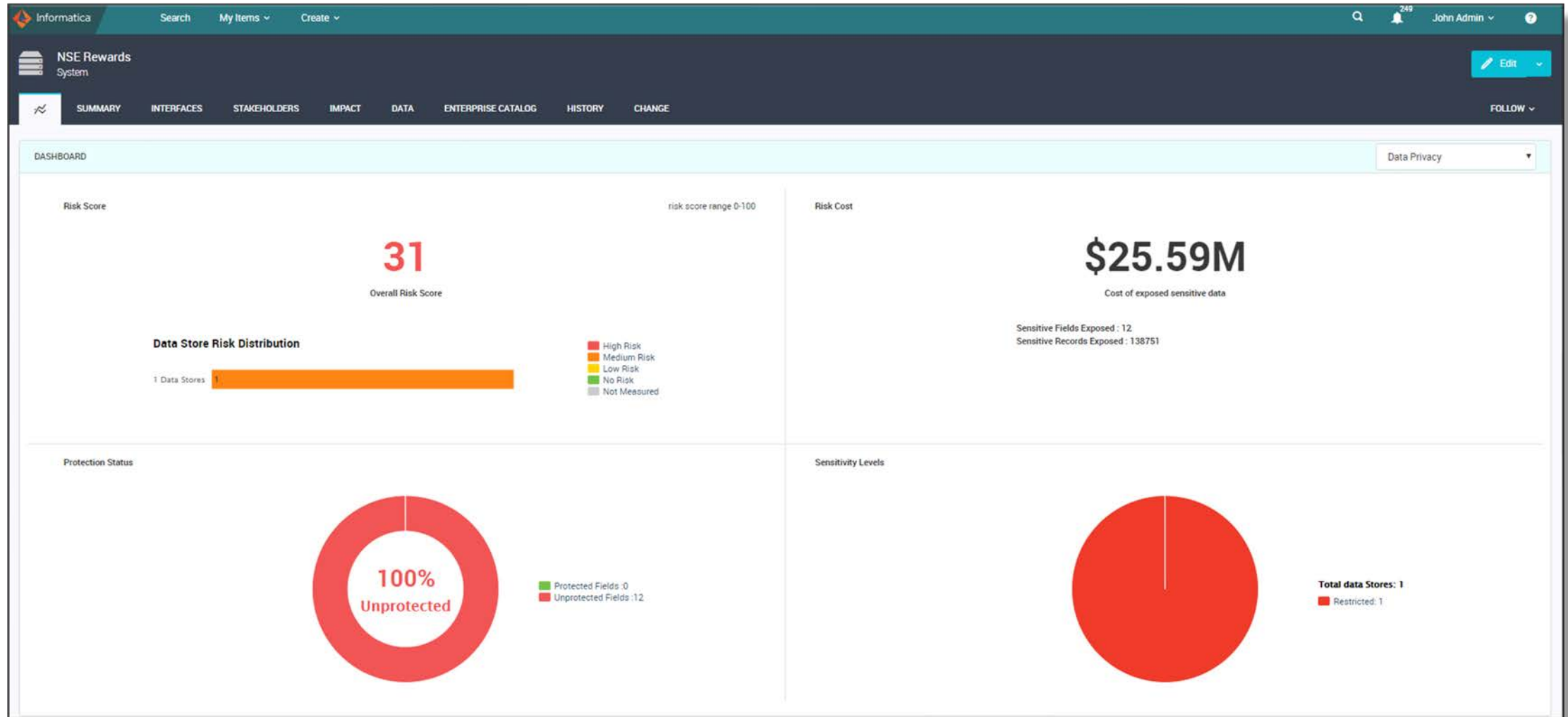

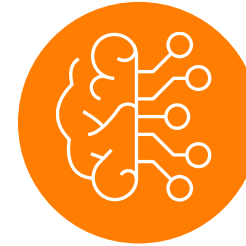
